## NOTICE OF PROPOSED GAS COST RATE CHANGES



## To Our Customers:

Peoples Gas Company LLC ("Peoples Gas") is filing a request with the Pennsylvania Public Utility Commission ("PUC") to increase your natural gas rates as of October 1, 2021. This notice describes the company's rate request, the PUC's role, and what actions you can take.

## Peoples Gas has requested an overall gas cost rate increase of \$5 million per year.

If the company's entire request is approved:

- The total bill for a Peoples Gas residential customer using 86 Mcf per year would increase from \$82.08 to \$87.84 per month or by 7.0%.
- The total bill for a Peoples Gas small commercial or industrial customer using 202 Mcf per year would increase from \$162.66 to \$175.98 per month or by 8.2%.

 The total bill for a Peoples Gas medium commercial or industrial customer using 2,393 Mcf per year would increase from \$1,566.16 to \$1,723.32 per month or by 10.0%.

To find out your customer class or how the requested increase may affect your natural gas bill, contact Peoples Gas at **1-800-764-0111**. The rates requested by the company may be found in Tariff No. 8. You may examine the material filed with the PUC which explains the requested increase and the reasons for it. A copy of this material is kept at Peoples Gas' office and is available on the company's website at www.peoples-gas.com.

The state agency which approves rates for public utilities is the PUC. The PUC will examine the requested rate increase and can prevent existing rates from changing until it investigates and/or holds hearings on the request. The company must prove that the requested rates are reasonable. After examining the

evidence, the PUC may grant all, some or none of the request or may reduce existing rates.

The PUC may change the amount of the rate increase or decrease requested by the utility for each customer class. As a result, the rate charged to you may be different than the rate requested by the company and shown above.

## There are three ways to challenge a company's request to change its rates:

1. You can file a formal complaint. If you want a hearing before a judge, you must file a formal complaint. By filing a formal complaint, you assure yourself the opportunity to take part in hearings about the rate change request. All complaints should be filed with the PUC as soon as possible.

- If no formal complaints are filed, the Commission may grant all, some or none of the request without holding a hearing before a judge.
- 2. You can send a letter to the PUC telling why you object to the requested rate change. Sometimes there is information in these letters that makes the PUC aware of problems with the company's service or management. This information can be helpful when the PUC investigates the rate request.

- 3. You can be a witness at a public input hearing. Public input hearings are held if the Commission opens an investigation of the

company's rate change request and if there is a large number of customers interested in the case. At these hearings you have the opportunity to present your views in person to the PUC judge hearing the case and the company representatives. All testimony given "under oath" becomes part of the official rate case record. These hearings are held in the service area of the company.
